1. My "Day at Queens Park" on Jan 22 2009 was Awesome!

"A Day at Queen's Park" was an eye-opening event for me.

Organized annually by RNAO, "A Day at Queen's Park" offers registered nurses the chance to attend the Ontario legislature and discuss health-care related issues with politicians.

I was skeptical at first. However, once involved in the process, I got hooked! I did not have expectations the politicians would do everything we asked; I just wanted to hear their responses. Most importantly, I got to see what RNAO does best – lobbying.

On the evening before the event, we gathered together for an informative session about lobbying. I was impressed with the RNAO preparation of the attendees. In a group session, RNAO presented the primary current political issues. Everyone separated into smaller groups with a leader. We discussed scripted questions and were coached in how to generate appropriate questions and responses. RNAO transformed the attendees into enthusiastic "lobbyists" overnight.

Early Thursday, we hustled to a Queen's Park meeting room to hear the politicians' speeches. This session included Health Minister David Caplan, John Tory and others. Afterwards, RNAO members asked questions on issues of poverty, pesticides, competitive bidding for community nursing, NP-led clinics and the need for 9,000 nurse positions. Some rhetoric was exchanged but there were positive replies. Doris Grinspun, Executive Director, RNAO, proposed that the leaders consider a minimum of 3,000 nurse positions this year for a concession on another issue.

Thursday afternoon, the attendees divided into smaller groups and, quite literally, jogged on the city streets to meet with individual politicians in many different government buildings. In these smaller groups, we had the opportunity to ask questions of the politicians and voice our opinions. Our nurse group leader guided the specific issues tabled.

By the end of the day, despite feeling slightly brain dead, I was excited about the opportunity for nurses to be heard.

On Friday, I attended the politically-focused RNAO Assembly Meeting. It gave the 140 attendees an opportunity for dialogue. We also heard a panel of presenters who gave information on the following important issues:

- Escalating poverty, and subsequent major increases in poor health
- Seniors Care Advocacy Council – the need for Long-Term Care to improve conditions for the elderly
- NP-led clinics are now a reality, but negativity continues with certain parties
- Physician’s assistants – a *NEW* position that requires one year of training
- Pesticide ban strengthening – toxic chemicals and increased cancer risk – the need for higher risk control
- Cease competitive bidding for Community Nursing Care agencies.

As OHNIG members, if we want to see changes in the implementation of health care, we should each individually express our concerns to our local politicians. They are interested in our input. This is something we often don’t get around to doing, but it is essential. If I can do it, YOU can do it!

2. OHNIG AGM Minutes Reflect 2009 Goal - Student Outreach Program

The OHNIG AGM took place by a teleconference meeting on Sat, Dec 6, 2008. OHNIG executives reflected on the END Goals established in 2007 [see sidebar]. It was decided that this year’s goal would include an outreach program entitled “*Student Outreach Program – Health and Safety Protection You Need to Know before Entering Your First Workplace*”.

OHNIG will prepare three Health and Safety Fact sheets. These will highlight ‘quick’ need-to-know facts about Health and Safety regulations, workplace responsibilities and risk protection.

The OHNIG AGM Dec 7th, 2008 **minutes** reflect our END Goals this year. OHNIG will do student nurse Health, Safety and Well-being awareness on

- leading causes of occupational and environmental health and safety risks in health care places
- ways to stay a “healthy worker”
- alliances that promote Occupational Health Collaboration
- Best Practice Guidelines Occupational Health and Environmental Safety
- techniques that eliminate or reduce risk exposures
- Occupational Health Nurse as a professional Nurse who provides Health, Safety and Well-being for workers

Our goal this year is to provide student nurses with a basic grounding in Health and Safety protection in the workplace. OHNIG intends to provide accessible, sustainable knowledge for long-lasting protection from workplace injury and illness.

3. Nursing Students “Health and Safety Protection” in Workplaces

The OHNIG executive leaders employed “reality thinking” and decided this year to focus on what student nurses need to know when they enter their first workplace. This safety information will continue to be helpful throughout their careers.

The OHNIG Student Outreach Panel planned a three stage program. The first stage starts with the panel developing three resource fact sheets that will be used for distribution. At the same time, a letter to the university school administration will announce student outreach *health and safety* at work, and ask how best to integrate this into the schools.

The second stage will be a timely distribution of the health and safety fact sheets. The OHNIG website will be restyled to accommodate access to a “Student Corner”, including the quick fact sheets, a student survey of effectiveness and links to resources the students need to know.

The last stage is at the OHNIG AGM in November. Invited students will be asked to participate with OHNIG members in a round table discussion (i.e. their student placement, perception of usefulness of the health and safety information and to discuss the student survey results). If the program works, OHNIG will continue it into the next year.

4. Barb Davies, Student Nurse Focuses Sight on Occupational Health Nursing

At the January RAO Assembly meeting I was delighted to meet with Barb Davies, an experienced Canadian student nurse, and hear about her experience in her Occupational Health placement. Barb eagerly expressed her interest in occupational health nursing.

“I became interested in Occupational Health Nursing during a second year clinical placement. An occupational health nurse had come to the floor to ensure all staff members had been given the flu vaccine. I was able to ask this nurse a few questions about Occupational Health Nursing. When I got home, I looked into this occupation and quickly learned that occupational health nurses work with the employee and the employer to maintain, promote, and restore health and safety in the workplace. This research led me to become a member of the RAO’s Occupational Health Nurses Interest Group and the Ontario Occupational Health Nurses Association. These two groups have guided my knowledge and learning about Occupational Health and how a nurse is there to help.

Now that I am in my last year of the BScN program at Laurentian University, I have had the opportunity to work with Occupational Health Nurses to gain a broader perspective. I have learned about the complexity involved in working with employers while keeping within the guidelines set by the Ministry of Labour and the Ministry of Health and Long-Term Care. I have been able to gain knowledge about disability management, health promotion, and management of several programs.
